TERMS & CONDITIONS

I understand that to be eligible for the Hudson Valley Gingerbread Competition at Mohonk Mountain House; I must agree to the following as indicated by my signature below:

- 1.) I must return my entry form by Email or fax, no later than 5pm on Friday, November 8, 2019. Entries are accepted on a first come basis and once we have filled the available spots registration will be closed, which may occur prior to the entry deadline.
- 2.) I must deliver my completed entry to Mohonk Mountain House on Sunday, December 8, 2019, between 8:30 – 10:30am.
- 3.) I must follow all of the Rules and Procedures set forth by Mohonk Mountain House.
- 4.) My entry is selected it will remain on display during Mohonk Mountain House’s holiday season through Wednesday, January 1, 2020. If I refuse to leave my entry and I am a winner I forfeit my prize in its entirety.
- 5.) If my entry is not selected to be displayed I must pick up my entry after the award ceremony on Sunday evening, December 8, 2019 or by 5:00pm on Monday, December 9, 2019. If my entry is selected for display then I must pick up my entry between the hours of 9:00am and 5:00pm on Thursday, January 2, 2020. Entries not picked up will be discarded the morning of Friday, January 3, 2020.

Permission is hereby granted to Mohonk Mountain House to print or otherwise duplicate the picture or likeness of my entry and/or myself with my entry for either internal or external release, this includes print and online publications, plus local and network television.
